2021-2022 Intradistrict Open Enrollment Procedure

(School-To-School Transfers)

Open Enrollment Dates: Thursday, January 7, 2021, through Friday, January 29, 2021

- Apply for Open Enrollment (OE) if you live within the Manteca Unified School District (MUSD) boundary and you want your child(ren) to attend an MUSD school other than your school of residence for the 2021-2022 school year.
- The Open Enrollment window will be from Thursday, January 7, 2021, through the close of school office hours on Friday, January 29, 2021. Late Open Enrollment forms will not be accepted.
- Open Enrollment Request forms will be available at your school site and on the MUSD website only during the OE window.
 - o If an online form is filled out by the parent, it is the parent's responsibility to ensure that the Open Enrollment form is received at the appropriate school within the OE window.
 - o The student is not required to be currently enrolled in an MUSD school.
 - o Parents can complete one Open Enrollment Request form per student.
 - o Open Enrollment forms are not processed on a first come, first served basis.
 - o Student signatures are not required on the Open Enrollment Request forms.
 - o All Open Enrollment Request forms will be date stamped to ensure they are received within the Open Enrollment window.
 - o A copy of the Open Enrollment Request form can be requested as proof of receipt.
- Open Enrollment forms are not available at the District Office and will not be available at any of the school sites or online after January 29, 2021. Late Open Enrollment forms will not be accepted.
- All Elementary Open Enrollments must be renewed yearly during the Open Enrollment window. Open Enrollment renewals can be filled out online or at the student's requested school.
 - Continuation of placement at the requested elementary school is contingent upon space availability in the requested grade, satisfactory attendance, behavior, and academic achievement of the student as defined by the receiving school Administration.
- High School Open Enrollment does not require renewal and the Principal can revoke the student's Open Enrollment during the first term/year of attendance at the requested high school. The Open Enrollment can be revoked if the student has unsatisfactory attendance, behavior, or grades as defined by the receiving school Administration.
- The requested school will mail the approval/denial letters to the parent through US mail by approximately March 31, 2021. If your student is receiving Special Education services, the Special Education Department will determine student space availability and placement. A letter will be mailed to the parent through US mail as soon as the determination is made.
- When you have been informed that your Open Enrollment Request has been approved, please contact your approved school within 7 days from the date of the letter to confirm your child's placement.

NOTE: Transportation to and from the requested school will be the responsibility of the parent/student applicant.
